**Medicaid Waivers for Child Services**  
PROGRAMS FOR CHILDREN WITH DISABILITIES

State-specific Medicaid waivers can help expand access to services for children with disabilities. Programs and eligibility vary by state, and current information should be verified with your state Medicaid office. **TEFRA/Katie Beckett**

- The Tax Equity and Fiscal Responsibility Act (TEFRA) of 1982 allows any state the option to extend Medicaid services to a child with a significant disability.
- States must adhere to the program's eligibility rules.
- Eligibility:
  - Based on the child's income and resources.
  - Does not count on deemed parental income.
  - The child must have a disability under SOAR rules that would require placement in a hospital, nursing facility, or intermediate care facility.

**1915 (C) Home and Community-Based Services (HCBS) Waivers**

- HCBS waives offer additional services that help provide care to children with disabilities in their homes.
- Can be categorized for different disability types, including developmental disabilities, intellectual disabilities, serious emotional disabilities, and physical disabilities, among others.
- Three levels of care (custodial, nursing facility, or intermediate care facility) define the level of services offered based on the diagnosed needs of the person with a disability.

**1115 Demonstration Waivers**

- States can use these flexible waivers to create state-specific programs or reform the state's Medicaid system. Some states have elected to use these waivers to provide home and community-based services for people with disabilities.

**State-Based, 1915(i), 1915(j), and 1915(k) Programs**

- There are state-based programs that are similar to the TEFRA option and can expand access to various services. These waiver programs can be identified with other state services:
  - 1915(i) Home and Community-Based Services, including respite and home and vehicle modification services.
  - 1915(j) Self-directed personal care services.
  - 1915(k) Personal assistance and in-home support.

### Celebrating the Month of the Military Child



In recognition of the [Month of the Military Child](#), we are highlighting resources for children and families in the armed forces community.

The U.S. Department of Veterans Affairs (VA) [Supportive Services for Veteran Families](#) (SSVF) grant program is critical to preventing and ending homelessness for Veteran families. SSVF can provide Veteran families with time-sensitive, housing-focused interventions, such as linking to mainstream resources and income supports that promote housing stability.

The [SSVF and SOAR Integration Toolkit](#) provides detailed guidance from the VA about incorporating the SOAR model into services for Veterans and their families. The [SOAR Online Course: Child Curriculum](#) trains caseworkers to assist children (under age 18) who are experiencing or at risk of homelessness and have a

serious mental illness, medical impairment, and/or a co-occurring substance use disorder to apply for SSI. Children with disabilities living in military families may benefit from the additional income and health insurance available with SSI and Medicaid eligibility.

### Sharing Our Successes

#### ***SOAR Success in Georgia***

*The following SOAR success story was submitted by LaTarnesha Washington, a SOAR-trained practitioner from the Department of Behavioral Health and Developmental Disabilities in Atlanta, Georgia.*

In late 2022, I received a referral for a participant who was experiencing homelessness and who had been working with a lawyer for a year before we initiated her case. After releasing herself from her lawyer, we started to work on her second appeal, and she chose the route of an ALJ hearing. As her appointed representative, I could advocate for her and obtain new records to submit a new testimony for her appeal.

During this process of waiting on a hearing date, we were able to get her connected to services through case management and medical services in one of our behavioral health agencies in the Georgia area. I followed up with the participant to stay updated on her disability.

After nearly two years of waiting and delays, the judge awarded her with SSI along with back payments granted to her. In the participant's words, "What a BLESSING!" The relief on her face was the joy in my heart. Using this model allowed me to represent the participant during her hearing and speak to the judge about what I had observed as her SOAR representative. Working with the applicant helped ensure she didn't have to experience this alone and had the support she needed during this process.

If I could give any advice to other SOAR practitioners, it is to have PATIENCE. We must have the ability to wait persistently until we reach our goal. Make sure you follow the SOAR model, and even when times seem rough or you get stuck or at roadblocks along the way, just continue to push through and keep encouraging your participant.

## Federal Updates

### **SSA Monthly Information Packet**

Each month, the Social Security Administration (SSA) releases an electronic publication known as the [Monthly Information Package \(MIP\)](#) for distribution to local media outlets by Public Affairs Specialists, office managers, and other employees engaged in public information/public affairs activities. Each issue contains the latest information on SSA programs, services, and initiatives. The April 2024 MIP includes information on Social Security fraud scams, financial literacy, *my* Social Security accounts, and support for small businesses.

## SSA POMS of the Month: Low-Stress Jobs

The [Program Operations Manual System \(POMS\)](#) is a resource used by Social Security employees to process claims for Social Security benefits. It provides detailed instructions and guidance on various aspects of benefit administration. The public version of POMS is accessible to everyone, so check it out! This month we will review [POMS DI 25020.010-Mental Limitations](#).

### What are the mental abilities needed for any job and why does this matter to our work?

Perhaps you have read this on an applicant's denial notice: *"Your mental health impairment is not so severe that it would prevent you from working in a stable, low-stress environment. Despite your mental health impairment, you can perform low-stress jobs, which may include employment as a Store Greeter, Restaurant Dishwasher, and Receptionist."*

These jobs are not necessarily "low-stress" or calm work environments. So, why did SSA find that the applicant can do this work despite their impairment-related symptoms, and how can we strengthen the record to include specific examples of limitations experienced by the applicant to preclude these jobs and avoid a denial?

## SSA Eliminates Overpayment Burden for Social Security Beneficiaries

Social Security [launched a comprehensive review](#) in October 2023 of agency [overpayment policies and procedures](#) to address payment accuracy systematically. As a result, in March 2024, [SSA announced](#) it will decrease Social Security beneficiaries' default overpayment withholding rate to ten percent (or \$10, whichever is greater) from 100 percent, significantly reducing financial hardship on people with overpayments. The change applies to new overpayments. If beneficiaries already have an overpayment with a withholding rate greater than ten percent and would like a lower recovery rate, they should contact SSA.

## Partner Updates

### NTTAC: Amplify Youth Voices and System of Care Summit

The National Training and Technical Assistance Center for Child, Youth, and Family Mental Health (NTTAC) hosts the [Amplify Youth Voice Collaborative](#) to recognize the power of creative writing as both a therapeutic tool and a way to center the voices and experiences of young people in systems of care by creating a platform for young people with lived experience of mental health challenges to express their unique stories in their own words.

In addition, NTTAC is holding a **no-cost** [System of Care Virtual Summit \(SOC Summit\)](#) on May 14-16, 2024. The SOC Summit is an opportunity for all children's mental health partners to reunite, renew, and re-energize their efforts to support children and young people with behavioral health needs, as well as their families.

### Medicaid Renewals and Homelessness: A Toolkit from Homebase

Due to the recently reinstated requirement for Medicaid members to renew their coverage every year, people experiencing homelessness are more at risk of losing coverage, as Medicaid members receive their renewal packets at their last known addresses.
